## BACKSIDES...

Before the "D.U. incident" fades into the sunset or becomes too much of a subject for jokes in the paper and in campus conversation; a few issues must survive. The primary value of the protest lies in the realization that if any one of us is demeaned, offended, harrassed, or degraded in any way, shape, or form we have the responsibility to show our concerns for our own self respect and for that of our peers - and not expect the faculty or administration to protect such important facets of our lives for us. Regardless of our status as carefree college students all of us must draw the line when it comes to taking a stand on rejecting demeaning attitudes, whatever form they take.

The fact remains that if a group of loud and angry people had not recently drawn the line the administration would have been unaware of the current of discontent in the Lafayette community, or at least would not have initiated anything to help alter it. The Conduct Committee and its choice of reprimand can never hope to put monetary value on the hurt and damage done. It is a request for positive efforts to be made on the behalf of fraternities, who have made it clear they recognize the gaps in communication and have the power to help close them.

The other sign of progress lies in the widening awareness of what sexual harrassment entails and how it must be dealt with. After discourse among faculty, President Ellis, Joseph Mignon (Director of Personnel) and Dean Kissiah, a new procedure for reporting such incidents has been established with Dean Sivilich at its base. Any student who has experienced any form of sexual harrassment should recognize Sivilich as the first step to beginning a resolution of this serious problem.

What must be determined is how much we value the concept of respect and how far we will go to maintain it in the Lafayette community.
